


ON 13/12/24 WE WERE ASKED TO BE SENTRIES FOR THE

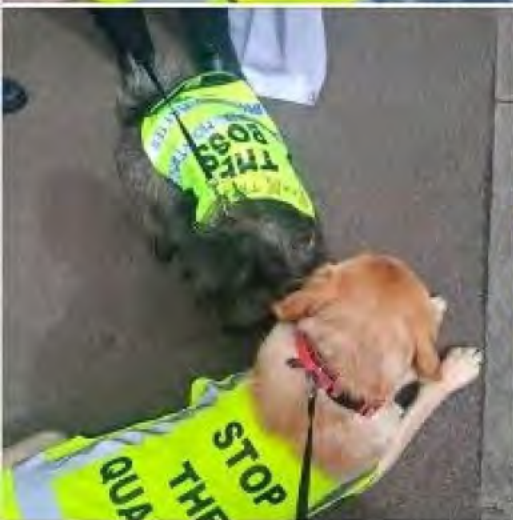

Hi all,

I attended the blast on Friday and was at the Pen Y Bryn monitoring point

I can confirm that an elderly gentlemen did come out of his house, would have been number 4 I think. He was complaining that the bag on top of the monitor that was being used for ballast was being used to deliberately make the results lower than they should be. We tried to explain to him that this was not the case and that the ballast is necessary to help take accurate results, and without the bag we would likely get a 'did not trigger' result. At this point he did get quite agitated and removed the bag from the sensor and put it on the ground and was insistent we should not put it on. We didn't want to get into a major argument with the chap so we did not put the bag back on at the time. During this time the machine had been on, waiting for the blast to go off – about 10 minutes later, just before the blast, the guy came out again, completely different person – said to put the bag on, which we did! The blast came soon after this, but unfortunately the batteries in the machine had run out – the operator did try and re-seat the batteries and swap them around but this did not work and by the time the blast went off we had not got the machine on again

I can confirm that when we first went to the monitoring point, and the monitor was switched on for the first time everything seemed to be ok and machine was definitely on so they were not dud batteries

As Julian has said it was not a particularly big blast and the numbers on the other monitor, by the water main, were all well within the limits
