### **MEETING MINUTES**


- 1. **Welcome and Chair introduction –** James Brown (JB)
- JB welcomed the group and asked all the attendees to introduce themselves and set out which organisations/groups they were representing.
- JB explained the agenda asked if the group was happy with the content of the draft minutes from the previous meeting. All members said they were happy with the content.
- JB went through the actions from the last meeting.
  - MMB to add minutes to Chipping Sodbury Quarry community web page. Complete.
  - ❖ JB to organise cutting back of hedges of verge at Southfields on Peg Hill. Complete – JF advised they would need cutting back again before the spring. LB said there were still allots of branches dropping on Brinsham Lane.
  - ❖ JB to share details of "smart quarry" at next meeting. Details in agenda.
  - JB to organise road sweeper to clean the road from the churned-up verges. Complete.
  - JB to send KC details of the open day. Complete.
  - ❖ AH to get contractor to clear broken trees (from the storm) in Brimsham Lane. Complete LB said there were still lots of branches dropping on Brinsham Lane.
  - MMB to send liaison group contact details to all members of the group. Complete.

### 2. **HMUK Update** – James Brown (JB)

- JB advised the group that Heidelberg Materials had received a government funding agreement to build the world's first fully decarbonised cement production process at its Padeswood plant in Liverpool. He went on to show a short video of the process. The video can be viewed at: <a href="Padeswood CCS">Padeswood CCS</a>
- LB asked where the project idea came from.
- JB explained that cement production is carbon intensive, with a large proportion
  of emissions coming from the chemical process involved in making cement. This
  means that significant reductions in emissions cannot be achieved just by using
  low carbon or renewable energy sources. The only way to produce the cement
  that the UK needs, without emitting large amounts of carbon, is to capture and

store these emissions before they enter the atmosphere. This is why investment in CCS forms a major part of the company's 2030 strategy to fully decarbonise.

- LB asked if the technology was new to Heidelberg.
- AH said it's more about the location of the Padeswood plant, and being able to capture CO<sub>2</sub>. Padeswood is uniquely placed to achieve this and the plant forms part of the HyNet project.
- SS said it really sets out the company as leading the way.
- AH said it was incredible technology and investment.



# 3. Environmental, landscape and biodiversity update – Alexandra Hemming (AH)

- AH said there was not much to update on since the last meeting. She said when
  we met in February felling before bird nesting season. A lot of ecology work had
  to be done. We bought and put up bird boxes and had already placed bat boxes,
  of which some were subject to licence which we obtained from Natural England.
- AH said some reports of anti-social behaviour were received from leaving brash
  in the woodland, so we arranged for it to be cleared and chipped, which is now all
  complete.
- AH said not much had been done over the summer due to license restraints or birdnesting but there are still some more trees to fell and possibly some road closures after Christmas needed to facilitate this

- LB said Brinsham Road has a lot of fallen branches, possibly the worst its's been.
- AH said a long dry summer hasn't helped and with all the felling it's made them more suseptable to wind and we would get our contractor to review.
- AH asked the group to report anything they see to Chipping Sodbury Quarry email address: **chippingsodburyquarry@uk.heidelbergmaterials.com**
- GM said South Gloucester's management plan was outstanding and wasn't sure if Ridge Wood was included, but he would find out.
- GM said a replanting plan will be confirmed once contact had been made with the felling contractors to ensure all felling work has been completed before they start. He said the path will also be looked at in terms of surface repairs if required. There is 750m of path but may have to split into three areas and do one area per year, as there would not be enough money in the budget to complete all at once. There is no desire to make the path in to a metalled track.
- AH said this came from a request from a resident to stone the path, it is being assessed as some areas may not be necessary.
- GM said once we have plans we will update everyone.
- AH said it may be worth getting the woodland assessed next year, looking at regeneration and species.
- LB said the gate at the top of Peg Hill is broken and the one at the top has disappearred.
- AH said the contractors still had a bit of mopping up with the felling and signage and we'll communicate when we know more about timescales.
- JF said a lot of people are complaining about the felling, so would it be possible to get something out publicly to let people know in advance.
- AH said the felling was communicated last time. There was a letter drop, a article in the Gazette and a visit to the care home to speak to residents.
- LB asked if the same species were being planted.
- AH said we are trying to diversify. A lot of the Northern part of the woodland was Ash, resulting in a an even aged canopy and few shrubs. We will now diversify the species to make the woodland more resiliant and biodiverse.
- AH said Great Crested Newt trials had come to an end after 5 years. There is one
  dog handler in the UK that uses a dog to sniff out the newts which has been very
  sucsessful.



- 4. Chipping Sodbury Quarry operational update James Brown (JB)
- JB advised the group of production volumes and targets for 2025.
- JB advised that sinking into level 4 in Brinsham East had been successful and opening level 5 this year.
- JB said Hampstead sink was nearly finished.
- LB asked when Hampstead will be finished.
- JB said this time next year hope to have it finished, weather permitting.
- JB said the Komatsu 950 excavator was working well and that the whole mobile plant fleet is Komatsu.
- JB explained to the group about "Smart Quarry". He said Komatsu can now take downloads from all the machines and can talk to each other, making them more efficient. Reducing fuel consumption and CO2.

# **Blasting**

- JB advised there had been 22 blasts this year to date.
- JB showed the group data from vibrograph and explaining the blasting is consistent and within the planning permissions.
- JB said since the last meeting in February he had received 2 complaints regarding blasting.

- LB said you don't normally get complaints for blasting.
- JB said we had been blasting in Hampstead; the resident who made the complaint was under the impression there would be no further blasting in that area. Following a to visit his house, he was happy once I'd explained the process.
- JF said a long time ago all the blasts used to be felt, but now we don't which is very good.

### Feedback & Community

- JB shared some information on complaints received by the site since the last meeting.
- RM said he had received just one complaint of dust on the Wickwar Road, outside the entrance of the quarry.
- JB said all trucks go through a wheel wash to prevent dust being carried outside of the quarry.
- JB said the quarry open day on the 14 June was a great success. 858 tickets were sold raising £1716 for Chipping Sodbury Festival. He said the exhibition at the Ridge was interactive and we had great feedback on the day about the quarry bus tour; many people having lived in the area for many years and never knew what was behind the gate.
- JB updated the group on some community engagement projects including schools that had visited the site, a donation of material to Brinsham Play Trail Project, some asphalt for the Ridings pathway and some material for the good times live event.

- AG said the artists and trustees were very grateful for the donation. He asked is anyone had any feedback from anyone about the event having an impact on the area.
- Both JB and LB said there was no impact or disruption as far as they were concerned.

### 5. Land and Mineral Planning update – James Brown (JB) Samantha Stagg (SS)

- Apologies were given that TM was unable to attend. SS said TM is expected to attend the next meeting and will provide a fuller update.
- SS confirmed that the planning application for the temporary haul road had been refused by South Gloucestershire Council earlier this year. The company's next steps are still under discussion, but if decisions are made ahead of the next meeting we will be in touch with local residents.





- SS said TM is continuing to work with SGC to work on the development of its local plan which goes to 2041, with the inclusion of Barnhill quarry for homes and small-scale employment. SGC has finished consulting on its local plan, and it is expected to go to the Inspectorate for review soon.
- LB asked if there had been testing in Brinsham West.
- JB confirmed some vibration testing and static noise monitoring had been carried out.

- LB asked how long it would be before extraction in Brinsham East is finished.
- JB said it would be about a year.
- LB said she would like to know asap about next steps for Brinsham West.

# 6. **AOBs**

- RM thank JB for the invitation to the group, and advised his remit was the High Street and asked if we could let the staff know there are some great places to eat.
- LB asked if the pump is switched off when it rains heavily or if it was automatic.
- JB confirmed the pumps are manually driven.
- LB asked if she needed to let someone know as earlier in the year it got really high, right up to the garage. Would it be possible not to pump when we have heavy rain.
- JB explained it's a natural fjord but he would look into this.
- LB asked if the haul road decision was going to be appealed and that, if so, requested if residents could have input at a meeting with HM prior to this and/or alternative submissions being made.
- SS reiterated that HM had yet to determine next steps but was committed to keeping residents informed. However, what shape that would take would depend on what HM's approach is re the proposal of the haul road going forward.
